As per the office order (06/39/140/JSACS/2021 dated 28.10.2021) a committee was formed to address the queries of the applicants on the primary screening process of the applications for various positions at JSACS. The first meeting was held on 28th October, 2021 under the chairmanship of Dr. S S Paswan, Additional Project Director, Jharkhand state AIDS Control Society, Ranchi, Jharkhand at the APD Chamber, JSACS along with other committee members. The purpose of the meeting was to review the documents of those applicants who had submitted their queries to JSACS.

In this regard, the committee had reviewed the queries of the five applicants for the position of Joint Director-TI, Joint Director-IEC and Assistant Director- Mass Media and the findings are given below-

The committee members had reviewed all the documents which had been submitted by the applicants and the applications which are fulfilling the NACO guideline have been recommended for shortlisting.

Thus, the application of Mr. Niraj Nayan and Mr. Ravi Prakash Singh for the position of Joint Director-IEC may be considered for shortlisting as both are fulfilling the criteria. The application of Dr Sharad Kumar for the position of Joint Director-TI may be considered for shortlisting as he is from Govt. Service (regular) and wish to serve in deputation at JSACS. It will be considered only after getting the approval from Project Director, JSACS.

The application of Mr. Tarit Chakroborty and Mr. Sharad Kumar for the position of Joint Director-TI will not be considered as Mr. Tarit Chakroborty and Mr. Sharad Kumar are not fulfilling the criteria of Experience and Qualification respectively. Similarly, the application of Mr Binay Basant Toppo for the position of Assistant Director – Mass Media will not be considered as he is not fulfilling the criteria of experience as mentioned in the NACO guideline.

The findings and recommendations of the committee are being placed to the Project Director, JSACS for necessary approval.
