Sealed tenders are invited for supply of Consumable as per requirement annexed with the document for one year under two bid system i. e. **Technical bid** and **Financial bid**.

Tender should be submitted in sealed envelope (for details please refer to terms & conditions) so as to reach this office or drop into the **Tender box** as per schedule given (last date of submission.)

The firm should submit the technical bid in sealed cover separately super scribing the cover word " **Technical Bid** " **mentioning due date for opening and name of the Tenderer**. Financial bid should not be quoted with the technical bid otherwise the tender will be rejected. The following documents must be submitted with the technical bid duly self-attested.

The following documents must be submitted with the technical Part.

- Participants shall furnish an earnest money deposit (EMD) in the form of a Bank draft for Rs. 30,000/- (Rs. Thirty thousand only) and draft to be drawn in favor of Jharkhand State AIDS Control Society.
- Xerox copy of Sales tax clearance certificate / Copy of monthly sales Tax Return for last 3 months.
- 3. Xerox copy of Sales tax registration certificate, Xerox copy of GST Registration Certificate.
- 4. Xerox copy of PAN card

- 5. Experience certificate for supply of these types of goods to any Govt. institutions/ Hospital/ Medical College.
- 6. Xerox copy of Drug license Certificate.
- Bidder should have Minimum annual turnover Rs. 50 lakhs continuously in last 3 financial years.
- 8. Undertaking as per enclosed Performa given in tender document.
- 9. Undertaking, stating that firm has never been black listed.

THE TEHNICAL BID AND FINANCIAL BID SHOULD BE SEALED SEPARATELY AND BOTH THE SEALED ENVELOPE MUST BE KEPT IN A SINGLE COVER SUPER SCRIBING THE WORD TECHNICAL BID AND FINANCIAL BID "MENTIONING TENDER NUMBER, DUE DATE FOR OPENING AND THE NAME OF TENDERER".

TERMS & CONDITION

- 1. Participating firms will have to submit their documents along with their rates.
- 2. **Before opening of the financial bid for items no 24 (Safe Delivery Kit)** one sets sample has to be provided to JSACS for quality check before opening of the financial bid . Financial comparative of the items no 24 will be prepared for those parties whose safe delivery kit is considered.
- 3. The approved rates will be valid for one year from the date of approval **or** finalization of new tender.
- 4. The tender must have the covering letter indicating the list of enclosures attached with the tenders.
- 5. Each page of the tender should be numbered and signed by the tenderer with seal of the firm.
- 6. The tenderer should specify the brand name, manufacturing company and specifications of each product.
- 7. Only single rate should be quoted for the prescribed specifications of each product/item. The rate quoted should be inclusive of all taxes viz. local/central sales tax etc and should be in words as well as in figures in the prescribed format given on pg 4-10.
- 8. Over writing, erasing, cutting or use of whitener must be attested, failing which the tender is liable to be rejected.

- 9. No advance payment will be made to selected supplier. Payment will be made after delivery.
- 10. Conditional offer will not be accepted.
- 11. Earnest money of the bidder will be returned after completion of the delivery of the material subject to the entire satisfaction of the society. No interest on Earnest Money will be allowed.
- 12. The entire quantity will have to be supplied to the society or its selected place within 21 days from the date of issue of the supply/ work order.
- 13. In no circumstances the tender rates will be increased after acceptance of offer. Goods are to be supplied within 21 days from the date of issue of work order; otherwise L.D at the rate of 0.5% per week, Maximum penalty will be 10% the deduction will be made from the current bill.
- 14. No separate cartage will be admissible for the delivery of the material at the office of the Society or at the given place. Items are to be delivered on door delivery basis (FOR)
- 15. The Society reserves the right to reject/accept any or all the tenders without assigning any reason.
- 16. Orders are likely to be placed in installments. Further quantities of the each Items for which tender is sought may be **increased** or **decreased** at the time of placement of orders.
- 17. After Placement of order the Jharkhand State AIDS Control Society, reserves the right to cancel / add/ modify any items.
- All disputes will be settled by Secretary cum chairman, JSACS Health & Family Welfare Department, Government of Jharkhand.
- 19. The EMD/s of successful bidders will subsequently be converted into as security deposit and would hold till the satisfactory completion of job stipulated, failing which it would be forfeited. EMDs of unsuccessful firms will be refunded immediately.
- 20. Sealed quotation may be deposited into the 'Tender Box' kept in the office of the Jharkhand State Control Society.
- 21. Only the rate of responsive bidders shall be consider.

- 22. Bid validity period shall be minimum of 90 days from the date of submission of bid.
- 23. The bidder firm may download the bidding documents from our official website www.jsacs.org.in and pay the amount of bidding documents by demand draft (Rs. 500/-) along with the bid in favour of Jharkhand state AIDS control society.
