Sealed tenders are invited from reputed manufacturers or their duly authorized agents for supply of Anti Retro Viral (ARV) Drugs annexed with the document under two bid system i.e. **Technical bid** and **price bid**.

Tender should be submitted in sealed envelope (for details please refer to terms & conditions) so as to reach this office by registered post or drop into the **Tender box** as per schedule given (last date of submission.)

The following documents must be submitted with the technical Part.

1. Participants shall furnish an earnest money deposit (EMD) in the form of a Bank draft for Rs. 5,000/- (Rs. Five thousand only) and draft to be drawn in favor of Jharkhand State AIDS Control Society.
2. Xerox copy of Sales tax clearance certificate / Copy of monthly sales Tax Return for last 3 months.
3. Xerox copy of GST Registration Certificate.
4. Xerox copy of PAN card
5. Experience certificate for supply of these types of Items to any Govt. institutions/ Hospital/ Medical College.
6. Valid Drug license Certificate Xerox Copy.
7. Valid GMP/WHO Certificate.
8. If the bidder is authorized distributor they have to submit authorization letter of the manufacturer.
9. Undertaking as per enclosed Performa given in tender document.
10. Undertaking, stating that firm has never been black listed.

TERMS & CONDITION

1. Participating firms will have to submit their documents along with their rates.
2. The approved rates will be valid for one year from the date of approval or finalization of new tender.
3. The tender must have the covering letter indicating the list of enclosures attached with the tenders.
4. Each page of the tender should be numbered and signed by the tenderer with seal of the firm.
5. Only single rate should be quoted for the prescribed specifications of each product/item. Should be in words as well as in figures in the prescribed format given on pg 4.
6. Over writing, erasing, cutting or use of whitener must be attested, failing which the tender is liable to be rejected.
7. No advance payment will be made to selected supplier. Payment will be made after delivery.
8. Conditional offer will not be accepted.
9. Earnest money of the bidder will be returned after completion of the delivery of the material subject to the entire satisfaction of the society. No interest on Earnest Money will be allowed.
10. The entire quantity will have to be supplied to the society or its selected place within 21 days from the date of issue of the supply/ work order.
11. In no circumstances the tender rates will be increased after acceptance of offer. Goods are to be supplied within 21 days from the date of issue of work order; otherwise L.D at the rate of 0.5% per week of the work order will be deducted from the payment.
12. No separate cartage will be admissible for the delivery of the material at the office of the Society or at the given place. Items are to be delivered on door delivery basis (FOR)
13. The Society reserves the right to reject/accept any or all the tenders without assigning any reason.
14. Further quantities of the each Items for which tender is sought may be increased or decreased at the time of placement of orders.

- 15.** After Placement of order the Jharkhand State AIDS Control Society, reserves the right to cancel / add/ modify any items.
- 16.** All disputes will be settled by Secretary cum chairman, JSACS Health & Family Welfare Department, Government of Jharkhand.
- 17.** The EMD/s of successful bidders will subsequently be converted into as security deposit and would hold till the satisfactory completion of job stipulated, failing which it would be forfeited. EMDs of unsuccessful firms will be refunded immediately.
- 18.** Sealed quotation may be deposited into the 'Tender Box' kept in the office of the Jharkhand State Control Society.
- 19.** Only the rate of responsive bidders shall be consider.
- 20.** Bid validity period shall be minimum of 90 days from the date of submission of bid.
- 21.** The bidder firm may download the bidding documents from our official website www.jsacs.org.in and pay the amount of bidding documents by demand draft (Rs. 500/-) along with the bid in favour of Jharkhand state AIDS control society.
