## **General Tender Terms & Condition**

### **A. Mode of Submission of Tender**

Tenders must be submitted in two different parts –

1. Technical Part
2. Financial Part

**Technical Part: a.** Documents submitted with Technical part as given below. All the information given must be supported by authenticated documents. The duly filled format along with all the supporting documents & original tender form with seal & signature on each page should be submitted. The technical proposal should be serially numbered and should be mentioned in given format (*without numbered pages will invite rejection of tender*)

**Financial Part: a.** Financial part must be submitted in given format in Price Bid (**Annexure-B**). The duly filled format signing each paper by the bidder will form the financial part. Change in Serial numbers in **Annexure-B** is not allowed. The Price bid should be submitted in a sealed envelope super- scribing on the envelope" PRICE BID" mentioning name of the tender and the name of tenderer.

**b. The tenderer should quote the rates (in Rupees only) (GST extra) on door delivery basis to the consignee's destination across the state.** There will not be any price negotiations after opening of envelop No.2 (Price bid) except with the lowest 1 (L1), if required. Hence all the tenderers are required to quote their most competitive rates.

### **B. Other Terms and Conditions:-**

1. Participants shall furnish an earnest money deposit (EMD) in the form of a Bank draft of Rs. 5,000/- (Rs Five Thousand only) for Test Kits. Draft to be drawn in favor of Jharkhand State AIDS Control Society.
2. Xerox copy of GST Registration Certificate.
3. Xerox copy of PAN card
4. The tenderer should specify the brand name, manufacturing company and enclose catalogue / Brochure of product.
5. Experience certificate of last three years for supply of these types of goods to any Govt. institutions/ Hospital/ Medical College.
6. Xerox copy of Drug license Certificate for Test Kits.
7. Manufacturer or their authorized agent can participate in the tender with valid authorization letter.
8. Undertaking as per enclosed Performa given in tender document page no 8.
9. Undertaking, stating that firm has never been black listed.

## TERMS & CONDITION

1. The tender document must have the covering letter indicating the list of enclosures attached.
2. Each page of the tender should be numbered and signed with index by the tenderer with seal of the firm.
3. The rates quoted in the financial part should clearly be in figures & words. In situation of any confusion the rate quoted in the words or purchase committee decision will be taken as rate quoted by the company.
4. The tender will be valid for a period of 12 months from the date of the acceptance of the tender.
5. Only the rate of responsive bidders shall be considered.
6. The Society reserves the right to reject/accept any or all the tenders without assigning any reason.
7. Orders are likely to be placed in installments. Further quantities of the each Items for which tender is sought may be increased or decreased at the time of placement of orders.
8. The payment will normally be made after the satisfactory supply of Consignment/ goods as per ordered specification of right quality and right quantity at various consignee address. TDS will be deducted directly from the bill amount as per government rules.
9. Sealed quotation may be deposited into the 'Tender Box' kept in the office of the Jharkhand State Control Society, Directorate Building, 4<sup>th</sup> floor, GVI Campus, Namkum Ranchi.
10. No separate cartage will be admissible for the delivery of the material at the office of the Society or at the given place. Items are to be delivered on door delivery basis ( FOR)
11. After Placement of order the Jharkhand State AIDS Control Society, reserves the right to cancel / add/ modify any items
12. In the event of the order being placed against any of the tenderer and if the tenderer fails to supply materials / items according to the terms and conditions of acceptance of Tender, the PROJECT DIRECTOR, JSACS, Ranchi shall be entitled to purchase such items from any other source and at such price as the undersigned shall be in his sole discretion, thinks fit.
13. In no circumstances the tender rates will be increased after acceptance of offer. Goods are to be supplied within 21 days from the date of issue of work order; otherwise L.D at the rate of 0.5% per week, Maximum penalty will be 10% the deduction will be made from the current bill.

### Specification:-

1. The kit should detect antibodies against treponema palladium in human serum and plasma.
2. The kit should be based on the principle of haemagglutination.
3. The kit should be able to detect antibodies both qualitatively and semi-quantitatively.
4. The red cells used in the kit should be avian cells and it should be coated with antigens of T palladium (Nichols Strain)
5. The sensitivity should be > 99.5% and specificity should be >99.5%
6. Total Incubation time of the test should not be more than 60 minutes.
7. Agglutination pattern should be stable for at least two and a half hours.
8. Agglutination pattern should be readable by naked eye.
9. The kit should have pack size of at least 100/200/500 tests.
10. The kit should include two levels of controls. Positive and Negative (controls should also be negative for HBV,HCV,HIV 1+2
11. The kit should have a shelf life of nine months at the time of receipt by the consignee.
12. The test should be capable of detecting both IgM and IgG antibodies.
13. Kit Storage 2-8 degree C.
14. The product must be approved under the provisions of Drugs and Cosmetic act and rules and or Medical devices rules 2017.
